# **IT Policy**

The purpose of the IT policy is to maintain, secure, and ensure legal and appropriate use of Information Technology infrastructure established by the Institution. The policy aims to protect the confidentiality, integrity, and security of the information assets that are accessed, created, managed, and/or controlled by the College. The Information assets of the college include computer systems, network devices, software, intranet, internet services, Software applications and other IT related hardware and software related services.

## Objectives of IT policy

- To provide all required IT resources to all stakeholders as per academic guidelines laid down by UGC.
- To provide IT infrastructure that would enable the students, staffs and teachers identify opportunities, improve performance and understand IT environment.
- Leveraging IT as a tool for socio-economic development.
- To ensure an effective annual maintenance plan which ensures maximum uptime of systems and devices.
- To ensure all IT resources are updated and available to students as per policies laid down by the college.

## Network (Intranet & Internet) Use Policy

The Technical Support Team is responsible for maintaining internet and intranet services of the college.

- The college has internet facility of 100 Mbps of SKYLINK. The whole campus is WI-FI
  enabled and internet availability is there at the nook and corner of the college campus for using
  at ease.
- · All systems are networked and secured.
- Firewalls are installed to provide protection against cyber -attacks, ransomware, or malicious network access attempts.

### Wi-Fi Use Policy

The Campus is fully Wi-fi enabled.

- Access points are located on all floors, thereby giving access to all classrooms, seminar halls, laboratories, learning centers, staffrooms and the administrative wing.
- Faculty is given Wi-Fi facility to access the internet.
- · Students are also given Wi-Fi access.
- · Guests, resource persons and speakers are given access to Wi-Fi on request.
